REOPENING OF PIER ONLY FOR WALKING FACILITY FOR MEMBERS ONLY  
FROM SAT. 12<sup>TH</sup> SEPTEMBER 2020, MORNING FROM 6.30 AM TO 10.00 AM &  
EVENING FROM 4.00 PM TO 7.00 PM

Dear Members,

Keeping in mind the Government directives and also taking into account the current weather Conditions, It has been decided to reopen Pier only for Walking Facility for members only from Sat. 12<sup>th</sup> September 2020, morning from 6.30 AM to 10.00 AM & evening from 4.00 PM To 7.00 PM with the following restrictions:

- a) Members have to maintain Social Distancing & Self-discipline while walking & wearing Mask is compulsory. Before entering the Pier the members have to do their thermal screening at the gate & Sanitize their hands.
- b) Members with any flu like symptoms or cold, cough etc. will not be permitted to enter the Pier. Members feeling unwell must not come to the Pier. It is the sole discretion of the attendant staff to allow entry to the Pier based on the members health status.
- c) Only a limited number of members for walking can be accommodated at the Pier of the Club. Crowding is not permitted under any circumstances at anytime. Members are requested to cooperate and must leave the Pier immediately after their walk. Members are not permitted to enter any other area of the Club premises and must leave the club immediately after their walk. Toilet Facility, provided at the Pier, only to be used.
- d) Chewing of Paan / Tobacco / Gutkha / Smoking is strictly prohibited.
- e) In the event of Rains / Bad weather no walking will be permitted.
- f) Members will be allowed to enter the Pier only on production of their membership card.
- g) No sitting in any part of the Pier area or a group chat. Sharing any eatables, beverages etc., strictly prohibited.
- h) No Guests will be permitted along with the member for walking in the Pier.
- i) Members Please note that the Govt. Permitted relaxations must not be misused and all the mandatory guidelines should be complied with.
- j) Members are requested to follow the above mentioned guidelines which can be modified from time to time.
