## Sub.: Reopening of the Sit Out Area by the Seaside for Members Only.

#### NAMASTE AND A WARM WELCOME TO ALL OUR MEMBERS

Members are hereby informed that w.e.f. Fri. 23<sup>rd</sup> October 2020 the Sit Out Area by the Seaside will reopen, the timings for which will be from 4.00 pm to 9.30 pm. The Staff at the Entrance of the Club will be monitoring the same and Members will only be allowed to enter on First Come First Serve basis, keeping in mind that this facility will be operating only with 33% Capacity.

Services will be limited as per Government Guidelines on the basis of norms listed below:

- 1. Members wishing to dine (dinner) in the Sit Out Area by the Seaside would need to contact the Catering Manager on Duty.
- 2. All Members including their spouse and children must carry their individual membership cards at all times as the same would be checked by the reception staff at the entrance.
- 3. Members entering the club will have to get their thermal screening done at the entry gate of the club and are requested to use the hands-free sanitizing facilities placed at the entrance and other surrounding areas of the club. Wearing of masks is compulsory at all times, except while eating and drinking.
- 4. The Members with any Flu like Symptoms or Cold, Cough etc. will not be permitted to enter the Club. Members feeling unwell must not come to the Club. It is the sole discretion of the attendant / reception staff to allow entry to the Club based on the Members health status.
- 5. Members are requested not to move around unnecessarily in the Sit Out Area by the Seaside or go on to any other members table in the interest and the safety of all other fellow members.
- 6. Members are requested not to disturb the seating arrangement of the Sit Out Area by the Seaside, which has been planned as per directions following Govt. norms, and no such request will be entertained for the same.

Service tables have been demarked in the Sit Out Area by the Seaside where the waiters will serve orders placed by the members, after which the members have to self-serve themselves from that service table. Please note that no Raw Food such as Salads, Lime, Chutneys and Onions etc. will be served. Only Packaged Drinking Water will be served on chargeable basis. Orders once placed cannot be changed / cancelled.
  - 8. Members are requested to use the washroom facilities on the ground floor.
  - 9. Members are requested to use their own pen for signing their bills when the same is presented to them.
- 10. Members are not permitted to use any other areas of the Club Premises and are requested to leave immediately after the use of the Sit Out area by the Seaside.
- 11. No Guests and Reciprocal Members will be permitted entry in the Club Premises.
- 12. No Members Personal Staff, Employee, etc. will be allowed in the Club Premises. Only attendant along with Physically Challenged Members will be allowed.
- 13. There will be no Valet Service till further Notice.
- 14. Chewing of Tobacco / Gutkha / Betel Leaf / Smoking is strictly prohibited in the Club Premises.
- 15. Members are prohibited from getting any outside Eatables, Beverages etc. into the Club.
- 16. Members should maintain social distancing and co-operate with the entire staff at all times.
