NAMASTE AND A WARM WELCOME TO ALL OUR MEMBERS

Members are hereby informed that w.e.f. Wednesday 07thOctober 2020, the limited menu items will be available for members in the Harbour View Restaurant. Kindly note that the Restaurant will be operating with 33% capacity.

The timings for the dine-in at the Harbour View Restaurant are as follows:

Lunch Timings: 12.00 NOON to 03.00 P.M.

Last Order: 02.30 P.M.

Dinner Timings: 06.30 P.M. to 11.00 P.M.

Last Order: 10.30 P.M. (by 11.00 P.M. the restaurant will shut completely).

Table reservation booking timings: Lunch – 11:30 A.M. to 02.00 P.M.

Dinner – 06.00 P.M. to 10.00 P.M.

Services will be limited as per Government Guidelines on the basis of norms listed below:

1. Members wishing to dine (lunch / dinner) in the Harbour View Restaurant would need to call on Nos. 8879781106 / 8879781108 / 8879781109, Land Line Nos. 22845025/71/75 (and ask for Harbour View extension when calling on the landline) for table reservations for the number of people coming to dine. Table reservation time / confirmation along with the menu will be informed via WhatsApp on concerned members mobile number given by the member. At the time of getting confirmation of their reservation, the members should forward the image of their Membership Card via WhatsApp to the dedicated mobile numbers mentioned above. Kindly note that at times there may be a possibility that you may not be able to get through the landline perhaps due to work being undertaken by the MTNL authorities.
2. Members have to pre-order their lunch / dinner via WhatsApp once the reservation has been confirmed. After the order is placed, your food order preparation will commence so as to be served to you at your reservation time. Kindly note that the tables would be kept reserved upto 15 minutes of the reservation time. Members are requested to reach at least 5 minutes before their reservation time. Orders once placed cannot be changed / cancelled and incase of No Show the total bill amount will be debited to the Members account.

3. Once the member arrives they will be guided by the Manager / Captain to the table reserved for them at the time of booking. No request for change of table will be entertained. All tables will be allotted with Table numbers and with a tent card displaying table numbers and contact numbers of Stewards /Manager's who would be available for Members services. Members should kindly note that at times all the items listed in the menu may not be available in the initial stages. Also no Raw Food such as Salads, Lime and Onion Slices, Salt n Pepper, Chutney n Pickles will be served. Only Bottle and Packaged Water will be served.
4. All Members including their spouse and children must carry their individual membership cards at all times as the same would be checked by the reception staff at the entrance.
5. Members coming to the Harbour View Restaurant are requested to use the hands-free sanitizing facilities placed at the entrance door and other surrounding areas of the club.
6. Members and their Children are requested not to converse loudly or move around unnecessarily in the restaurant or go on to any other members table in the interest and the safety of all other fellow members.
7. Members are requested not to disturb the seating arrangement of the restaurant, which has been planned as per directions following Govt. norms, and no such request will be entertained for the same.
8. Service tables have been demarked in the restaurant where the waiters will serve orders placed by the members, after which the members have to self-serve themselves from that service table.
9. Only paper napkins will be kept on each table and no cloth napkins and finger bowls will be provided. As such Members are requested to use the washroom facilities should they wish to do so.
10. Members please note that there will be no cash / debit card / credit card transactions for orders placed for dining. Members are requested to use their own pen for signing their bills when the same is presented to them. All billing amounts will be debited to members individual accounts.
11. Temperature of the A/Cs need to be set as per directions following government norms.
12. Members kindly note that no Liquor will be served in the Harbour View Restaurant until the Govt./ State Excise permission is received.
