- 1. The election to elect not more than 15 Members of the Managing Committee (Board of Directors) will be conducted by Remote e-voting and Electronic voting system. The Electronic voting system for both the businesses i.e. Ordinary business and Special business shall be conducted on Wednesday 25th September 2024 from the start of Annual General Meeting and remain open for four (4) hours. The Electronic voting system for all the Items i.e. Item No. 1 to Item No. 14 will start together.
- For procedure of Remote E-voting/ Electronic voting system, kindly refer the Appendix to the Notice for the 100TH Annual General Meeting. The remote e-voting period begins on Friday 20TH September 2024 from 9.00 A.M. (IST) and ends on Tuesday 24th September 2024 at 5.00 P.M. (IST). The remote e-voting module shall be disabled for voting thereafter.
- 3. The entry of the Members / Reciprocal Members / Guests to enter the Club Premises on Wednesday 25th September 2024 shall be strictly restricted as per the other notice dated Saturday 24th August 2024.
- 4. It may be noted that the aforesaid list of Candidates is subject to the condition that the stop payment option is not exercised by the candidates in respect of DD/ Banker's Cheque/ Pay orders/NEFT/RTGS given by them. In case, the payments are not realised, there will be no payment in the eyes of law. Therefore, there will be no payment of Deposit in accordance with Section 160 of Companies Act, 2013. The said candidates whose amount is not realised will lose their right to contest the forthcoming election to the Managing Committee. Their names will not be included for the purpose of voting by remote e-voting and by Electronic voting system during the Annual General Meeting.
